CSA Travel Protection's Freestyle and Freestyle Luxe Plans are designed to provide you with sound, reasonably-priced insurance coverage and assistance services so you can relax and enjoy your trip.



## PROTECT YOUR TRIP

### Trip Cancellation

Provides reimbursement for unused, non-refundable, pre-paid trip costs if you are prevented from taking your trip due to a covered reason.

### Trip Cancellation for Any Reason

Available as an option on the Freestyle Luxe Plan. Not available to residents of New York.

Provides reimbursement up to 75% of non-refundable trip cost when you cancel your trip for any reason. Available as an optional upgrade if purchased within 24 hours of initial deposit. Other conditions apply. Please see a sample Description of Coverage or Insurance Policy for details.

### Trip Cancellation for Business Reasons

Available as an option on the Freestyle Plan and included with the Freestyle Luxe Plan.

Provides additional business-related coverage, should you have to cancel your trip. Available if purchased prior to or within 24 hours of final trip payment.

### Trip Interruption

Provides reimbursement for unused, non-refundable, pre-paid trip costs if your trip is interrupted due to a covered event. Also provides reimbursement for the additional transportation cost to return home or rejoin your group.

### Trip Interruption for Business Reasons

Available as an option on Freestyle Plan and included with Freestyle Luxe Plan

Provides additional business-related coverage, should you have to interrupt your trip. Available if purchased prior to or within 24 hours of final trip payment.

### Travel Delay

Provides reimbursement for reasonable expenses incurred such as accommodations, meals and local transportation if you are delayed 6 hours or more during your trip due to a covered reason.

### Missed Connection

Available if coverage is not available elsewhere

Provides benefits for additional transportation expenses, reasonable local accommodation expenses and unused land or water arrangements if you miss your cruise or tour departure as the result of the cancellation or delay of 3 hours or more of your regularly scheduled airline flight due to adverse weather.

## PROTECT YOUR STUFF

### Baggage Coverage

Provides coverage for loss, theft or damage to your baggage and covered personal effects during your covered trip.

### Baggage Delay

Provides reimbursement for the purchase of necessary items if your baggage is delayed for more than 24 hours during your covered trip.

## PROTECT YOUR RENTAL CAR

### Rental Car Damage Coverage

Not available to residents of Texas

Provides primary coverage if your rental car is damaged due to collision, fire, flood, theft, vandalism, windstorm or hail.

## PROTECT YOURSELF

### Medical and Dental Coverage

Provides coverage for the necessary medical, surgical and emergency dental care costs if you become sick or accidentally injured while on your covered trip. Coverage is in excess of your standard coverage, except where prohibited.

### Emergency Assistance and Transportation

Benefits include transportation to the nearest suitable medical facility, help to return home if medically necessary and up to \$10,000 in expenses for a companion to visit you if you are traveling alone and are hospitalized for more than 7 days.

### Accidental Death and Dismemberment – Air Flight Accident

Provides coverage if you are injured by an Air Flight Accident, which occurs while you are on a trip, and you suffer the loss of life or limb within 365 days of the Air Flight Accident.

### Accidental Death and Dismemberment – Travel Accident

Available with the Freestyle Luxe Plan only

Provides coverage if you are injured by an accident, which occurs while you are on a trip, and you suffer the loss of life or limb within 365 days of the accident.
